The beginning Australian Digital Theses (ADT)

- Year 2000
- Funded by the Australian Research Council (ARC)
- Managed as a CAUL project
- Local software hosting at each university
- Centralised metadata harvesting
- Most universities progressed to having digital only theses acceptance

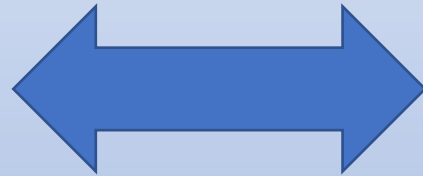
Institutional OA research publication repositories

- 2007 Australian Research Council (ARC) provided top-up funds for all Australian universities to implement an open access institutional repository for research outputs
- ASHER funding
- ARROW project – VITAL repository software taken up by about half the institutions

Institutional research data metadata repositories

- 2010 -
- Funded by the Australian National Data Service (ANDS)
- Delivered Research Data Australian (RDA) metadata harvesting service and central data portal
- Each institution was funded to implement a data repository. Most were metadata only with linking to data stores
- ANDS also funded a number of content focused “Seeding the commons” projects
